Bond Measures A & B

Since bond measures A & B were approved in Nov. 2015, construction and improvement projects have progressed steadily and transformed our facilities. This report shows our progress on those measures in 2021-22.

Measure A provided \$108 million for elementary and middle schools; and Measure B invested \$161 million into high schools.

As we were headed into the sunset on Measure A & B projects, new bond Measures B & C were approved by voters in June 2022, providing up to \$216 million for high school projects and \$152 million for elementary and middle schools.

We believe that by building trust and demonstrating progress as promised, we will continue to deliver the best-possible facilities to our students, staff, and community.

Davidson Middle School HVAC Upgrade Phase I

Completed 11.8.2021 43,387 square feet

New HVAC system provides upgraded heating, air conditioning, and ventilation in wings 10-50. The wings are scheduled on the district-wide energy management system which includes CO2 detection sensors.

Bahia Vista Elementary School HVAC Upgrade

Completed 11.8.2021 24,000 square feet

New HVAC system provides upgraded heating, air conditioning, and ventilation in classrooms. These rooms are scheduled on the district-wide energy management system which includes CO2 detection sensors.


Terra Linda High School Campus-wide Exterior Painting Project Completed 8.18.2021 181,000 square feet

The Terra Linda High School campus, including the District office, was brightened through exterior surface preparation and painting of campus buildings.

The breezeway between the 100 and 300 wings of the main building underwent structural repair and handrails were installed in the same area.

The campus was beautified through surface preparation and painting. Other work included in this project: repairs to down spouts and conduit coverings; door replacement and repair; and a new fencing enclosure for the natural gas service area.

Portable Removal

Completed 5.5.2023 19,300 square feet

Leased portable buildings and associated infrastructure were removed, including demolition of a shade structure; preparation of asphalt concrete and drainage adjacent to buildings; coating and striping of existing asphalt concrete; and installation of two basketball courts.

San Rafael High School STEAM Building (Science, Technology, Engineering, Arts and Math) Completed 11.28.2022 18,566 square feet

A new two-story STEAM building was constructed, including landscaping and site improvements. The building includes: science and math classrooms; a ceramics classroom/studio; a physics academy; a fabrication lab with state-of-the art equipment and collaboration areas; along with restroom facilities.

AD Building ModernizationCompleted 11.21.2022 10,500 square feet

Existing offices were converted into a wellness center and four new classroom spaces. The Wellness Center provides support and counseling spaces for students. Restrooms on the second floor were modified and a new single occupancy restroom was added.

Terra Linda High School New Gym + Frontage Improvements Completed - 4.21.2023 22,000 square feet

An unoccupied cafeteria building was replaced with a new competition gym building. The complex features a 100' basketball court with bleacher seating for up to 1200 spectators, three team rooms, a conference room, a sports medicine room, offices for staff, a snack and ticket sales room, an athletic training center, and enhanced parking.

Power lines along the front of the Terra Linda campus were relocated underground, allowing the redesign of the entire campus frontage.

A new bike path was added to the campus, and Nova Albion Way was striped for bike lanes. New parking and drive aisles were added, along with street and site lighting, and new landscaping.

This sustainable project uses reclaimed water, daylight-responsive lighting controls, low-flow plumbing fixtures and heating, and features ventilation and airconditioning systems powered by 60% renewable energy,

Davidson Middle School Phase II HVAC Upgrades/Roofing

Start Date: Summer 2022 HVAC 28.592 square feet Roofing 44,264 square feet

Replacement of HVAC systems with electrical-only systems that do not rely on natural gas, including addition of cooling to certain spaces. The work includes replacement of existing mechanical systems in: Wing 10 Administration: Wing 30 Library: maker's space; band rooms; and annex. Air conditioning will be added to Annex classrooms. In addition, replace roofs on the 20s and 30s wings; band, maker space, and music rooms; as well as the annex.

Venetia Valley K-8 School Restroom Building

Start Date: Summer 2023

Add a new building to accommodate single occupancy student and staff toilet rooms, janitor closet. This facility will provide access from the Middle School area of campus.

Terra Linda High School East Parking Lot Quad Start Date: Summer 2023

58.000 square feet

Demolition of existing hardscape and replacement with new finishes, including new seat walls, site concrete, stairs, retaining walls, landscaping, site lighting, paving, and striping of staff parking lot.

Ceramics Studio

Start Date: Summer 2023 3,400 square feet


Demolition of existing kiln shed, and construction of a new ceramics studio building with space to accommodate three electric kilns and one gas kiln: landscaping and flatwork at the perimeter of the building; and new decorative fencing.

Career Technical Education Shade Structure and Admin Canopy

Start Date: Summer 2023 1.800 square feet


Installation of a new shade structure at the rear of the engineering/woodshop building, with lighting and electrical receptacles added to the structure. Installation of new 8' fencing around the perimeter, along with decorative security fencing at various locations on campus. A shade canopy will be added to the the TLHS Administration building entrance.

Fiscal and Performance Audit

As required by Measures A and B Bond language, each year a fiscal and performance audit of Measure A and B expenditures is conducted. The certified public accounting firm of Nigro & Nigro performed the required 2021-22 financial and performance audits for the fiscal year ending June 30, 2022. The auditor issued an unqualified opinion that no deficiencies or unallowable expenses were discovered. The audit reports were presented and approved by the District's Board of Education at their meeting on March 27, 2023. With this action, it was concluded that San Rafael City Schools complied in all material respects with Measures A and B requirements to expend bond proceeds only on the school facilities projects specified in each. The audit was received by the Citizens' Bond Oversight Committee on March 22, 2023.

Statement of Compliance

This 2021-22 CBOC Annual Report will be submitted to the Board of Trustees in August, 2023 by the San Rafael City School District Measures A & B Citizens' Bond Oversight Committee.

The Committee advises that, to the best of its knowledge, the San Rafael City School District is in compliance with the requirements of Article XIIIA, Section I(b) (3) of the California Constitution. Furthermore, the Committee has reviewed expenditure reports produced by the District that confirm that (a) bond proceeds have been expended only for the purposes set forth in the ballot measures; (b) and not for any other purposes, including teacher and administrative salaries and other school operating expenses; (c) and that bond proceeds have been maximized.
