PART E - BIDDER QUESTIONS

Question 1: The bid docs specify a fairly extensive office site trailer furnished with copiers, phone lines, etc. Will this really be needed for this demo project?

Answer: A construction trailer will not be required for this project and is at the discretion of the contractor for needs required during construction.

Question 2: Is there a requirement to have a licensed surveyor on this job?

Answer: Yes, the finished condition of the work area should be surveyed by a licensed surveyor.

Question 3: To clarify on the permits, will the general just go and pick up a demo permit at the county building department? (I am assuming the application for the necessary permits is already in.) Will the district fully reimburse the general for the permits?

Answer: The contractor is not required to file a permit or pay permit fees. This project is under the jurisdiction of DSA. It is exempt from DSA review per IR A-22.

Question 4: Is there is SWPPP required for this project since it is in the summer?

Answer: Yes.

Question 5: Please confirm if there is refrigerant recovery from any roof top units, etc. to be included in the bid price.

Answer: There is no air conditioning for the buildings in the demolition scope.

Question 6: Will there be a project sign required as noted in the specs?

Answer: A construction sign is required, but a 4'x6' single color vinyl banner secured to stakes would be acceptable.

Question 7: I am assuming there will be no O & M manuals required for this project?

Answer: O&M manuals are not required.

Question 8: Are we to include Builders Risk Insurance, as noted in the special conditions insurance section, for this project?

Answer: Revise the insurance requirements per the attached excerpt from <u>Document 00 72 13</u>. Builders Risk is required.

Question 9: Is the badging requirement in effect since this is a summer project?

Answer: The project superintendent (supervisor in control of the workers) must abide by all badging and security standards. The superintendent will be responsible for all employees.


