- Item 1-18:Question 18: On plan sheet C3.0 there is an 8' wide strip of asphalt approx: 130' Long.
On plan sheet A1.1 this same 8' section is called out as concrete.Response 18: Sheet A1.1 should be followed. The path is to be concrete.
- Item 1-19: Question 19A: There is a specification for epoxy flooring. Please clarify when this applies.

Response 19A: See Response 16 above.

Question 19B: The plans call for the existing restroom building to be demolished after construction of the new restroom building but do not specify what will go in place of the building. Please confirm that we are patching the asphalt around the building to match the existing.

Response 19B: Confirmed. Patch area to match existing asphalt.

Question 19C: The perimeter fence also butts up to the existing restroom building. Please confirm that we are adding new fencing at the location of the existing restroom building to close off the perimeter to the school.

Response 19C: Provide additional fencing to match adjacent fencing including slats.

- Item 1-20:Question 20: The Non-Collusion Declaration is missing, but the bid documents state that
it is required to be submitted with our bid.

- Item 1-21: Question 21: Subsection 1.04.A of specification section 01 32 13 mentions use of Primavera Project Planner. Please confirm that Microsoft Project is acceptable to use on this project.

- Item 1-22: Question 22: What is the liquidated damages penalty? Response 22: Per Section 00 52 13, Agreement, Item 6 Liquidated Damages "Time is of the essence for all work under this Agreement. It is hereby understood and agreed that it is and will be difficult and/or impossible to ascertain and determine the actual damage that the District will sustain in the event of and by reason of Contractor's delay; therefore, Contractor agrees that it shall pay to the District the sum of <u>five hundred</u> dollars (\$500) per day as liquidated damages for each and every day's delay beyond the time herein prescribed in completion of the Work. "
- Item 1-23:Question 23A: Please confirm the second set of drawings on the districts website and
builders exchange labeled Venetia Valley Field Storm drain set is apart of the project and
is to be included on the base bid.Because 22A: Both sets of drawings are to be included in the base bid.

Response 23A: Both sets of drawings are to be included in the base bid.

Question 23B: Sheet C3.0 identifies a new walkway adjacent to the new building. The shading of this walk way is inconsistent with the call out for the AC or concrete identified on the drawings, but detail 5 identifies the header for this walkway, and that detail identifies this walkway as AC paving. Sheet A1.1 keynote S18 identifies this walkway as new concrete.

Response 23B: The walkway is to be concrete.

- Item 1-24:Question 24: Please confirm where the Venetia Valley School Field drawings scope of
work is in relation to the Venetia Valley School Middle School Restroom Addition
drawings scope of work.Response 24: The drainage swale is located on the north edge of campus along the
fence line.
- Item 1-25: Question 25: I'd like to submit Terrazzo & Marble Supply Decorative Trowel Down Flooring System as an equal to the Dex O Tek Terracolor flooring system. Our system out performs Dex O Tek in the key areas of Abrasion Resistance, Compressive Strength, Flexural Strength, and Tensile Strength. We also offer a more comprehensive warranty.
