BOND MEASURES A & B

In November 2015, local voters approved two school bonds for San Rafael City Schools: Measure A was for \$108 million for elementary and middle schools; and Measure B provided \$161 million for high schools.

These bond measures funded much needed capital improvements for our facilities to greatly enhance the learning environment and address infrastructure needs.

Construction at Venetia Valley K-8 included instructional and support facilities providing:

- A new two-story building with 20 modern classrooms used for a broad range of curriculum, including STEAM (Science, Technology, Engineering, Arts and Math), special education and student support spaces
- Expanded play and outdoor learning spaces
- A new multi-purpose building with assembly space, and a kitchen with a serving area for the entire school
- Redesigned drive entrance to help minimize school traffic on San Pedro Road

Louver Installation Completed 2.1.2021

Classroom louvers were installed, providing pressure relief when the newly installed mechanical units are functioning in the economizer mode. This mode allows 100% outside air.

Portables Demolition Completed 4.8.2021


Demolition and limited abatement of 10 portable buildings no longer needed on campus.

TERRA LINDA HIGH SCHOOL

STUDENT COMMONS/AMPHITHEATER COMPLETED 5.19.21 30,455 SQUARE FEET \$31.4 MILLION





The new two-story Student Commons and Amphitheater creates a vibrant new center on the campus. The Commons include a library, cafeteria, kitchen, music and drama classrooms, theater, career center, and a student lounge. The amphitheater features ample shade and seating options to enjoy student performances.

MODERNIZATION

Completed 5.25.21

Many areas of the TLHS campus were modernized to better use existing classroom space, outdoor areas, athletic facilities, and to provide significant improvements in energy efficiency. The projects include refinishing of the gym floor and installation of new bleachers; remodeling of classrooms; a new Innovations Hub courtyard; and installation of new windows, doors and storefronts at Terra Linda High School and the District Office building.

AIR CONDITIONING PHASE 2

Completed 3.15.21

Air conditioning was installed in the remainder of SRHS buildings to improve ventilation, filtration, and comfort in the indoor learning environment.

BAHIA VISTA ELEMENTARY & DAVIDSON MIDDLE SCHOOL

HVAC Upgrades Completed 11.8.2021

New HVAC systems provide upgraded heating, air conditioning, and ventilation in classrooms. Additionally, these rooms are scheduled on a district wide energy management system which includes CO2 detection sensors.

TERRA LINDA HIGH SCHOOL

Exterior Painting Completed 8.8.2021

All buildings on the Terra Linda High School campus were painted.

TERRA LINDA HIGH SCHOOL

Breezeway Waterproofing & Handrailing Replacement Project Completed 11.12.2021

The breezeway between the 100 and 300 wings of the main building underwent structural repair. The repair eliminated past issues of water accumulation on the walking surface, and loose railings, due to age, that began pull away from the structural connections.

PROJECTS IN PROGRESS MEASURE A ELEMENTARY & MIDDLE SCHOOL PROJECTS

DAVIDSON MIDDLE SCHOOL HVAC Upgrades, Phase II

Replacement of HVAC systems with electrical-only systems that do not rely on natural gas, including addition of cooling to spaces which only have heating. The work includes replacement of existing mechanical systems at Wing 10 Administration and Wing 30 Library.

VENETIA VALLEY SCHOOL Field Restoration

Restoration of Venetia Valley field, installation of new track and modification to rear parking lot.

PROJECTS IN PROGRESS MEASURE B HIGH SCHOOL PROJECTS

SAN RAFAEL HIGH SCHOOL STEAM Building (Science, Technology, Engineering, Arts and Math)

Construction of new two-story STEAM building, including science classrooms, a ceramic classroom, a design/engineering lab, other classroom spaces, and restroom facilities.

AD Building Modernization

Soft demolition of existing office wings to create new classrooms and offices. Mechanical and ventilation system installation, new plumbing, electrical, lighting, new interior partitions, wall finishes, floor finishes, new ceilings, and trim. Associated minor repairs to existing building interior.

Painting and Exterior Repairs

Painting the campus as well as miscellaneous repair work and removal of electrical, data and cabling; installation of fencing around gas regulator; replacement/repairs to metal screens, installation of shrouds around various electrical, mechanical & plumbing items surface mounted to buildings, installation of gutters and downspouts at select locations.

TERRA LINDA HIGH SCHOOL New Gym + Frontage Improvements (Design/Build

New construction of 21,000 square foot competition gymnasium and associated site work. Renovation and reconfiguration of the campus frontage improvements to support the new building and site entry/exit.


CBOC Meeting Dates/Topics

FISCAL AND PERFORMANCE AUDIT

As required by Measures A and B Bond language, each year a fiscal and performance audit of Measure A and B expenditures is conducted. The certified public accounting firm of Nigro & Nigro performed the required 2020-21 financial and performance audits for the fiscal year ending June 30, 2021. The auditor issued an unqualified opinion that no deficiencies or unallowable expenses were discovered.

The audit reports were presented and approved by the District's Board of Education at their meeting on March 14, 2022. With this action, it was concluded that San Rafael City Schools complied in all material respects with Measures A and B requirements to expend bond proceeds only on the school facilities projects specified in each. The audit was received by the Citizens' Bond Oversight Committee on March 7, 2022.
