## SAN RAFAEL CITY SCHOOLS (San Rafael City Elementary District / San Rafael City High School District) APPLICATION FOR INDEPENDENT CITIZENS' OVERSIGHT COMMITTEE

The Board of Education of San Rafael City Schools is seeking qualified, interested individuals to serve on a committee of community leaders which will serve as the Independent Citizens' Oversight Committee ("COC") for the implementation of the San Rafael City School District's Measure A and San Rafael City High School District's Measure B school facilities bond programs.

### **Proposition 39 Bond Election**

On November 3, 2015, voters residing within the San Rafael City School District passed Measure A. Measure A is a \$108,225,000 bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's elementary schools. Proposition 39 required a 55% supermajority for approval; Measure A was passed by 66%.

On November 3, 2015, voters residing within the San Rafael City High School District passed Measure B. Measure B is a \$160,500,000 bond measure that authorizes funding for needed repairs, upgrades, and new construction projects to the District's high schools. Proposition 39 required a 55% supermajority for approval; Measure B was passed by 67%.

#### **Establishment of a Citizens' Oversight Committee**

After a bond authorized under Proposition 39 is passed, state law requires that San Rafael City Schools Board of Education appoint an Independent Citizens' Oversight Committee to work with the Districts. The Board of Education has created one Independent Citizens' Oversight Committee, which will have oversight responsibility for both Measure A and Measure B.

#### **Committee Responsibilities**

In accordance with Education Code Section 15278(b), the Citizens' Oversight Committee shall:

- Inform the public concerning the District's expenditure of Measure A and Measure B bond proceeds;
- Review expenditure reports produced by the District to ensure that Measure A and Measure B bond proceeds were expended only for the purposes set forth in Measure A and Measure B, respectively; and
- Present to the Board in public session, an annual written report outlining their activities and conclusions regarding the expenditure of Measure A and Measure B bond proceeds.

The Bylaws which govern the Citizens' Oversight Committee are attached to this Application.

#### **Appointment of Committee Members**

All appointments will be made by the Board of Education from applications submitted to the District.

#### **Time Commitment and Term**

Initial appointments will be staggered, such that some of the initial appointees will be appointed to serve one full two-year term. The other initial appointments will serve a one-year term, but will be eligible for reappointment by the Board of Education for a second and third two-year term.
